Attorney Lara Bracamonte Davila sees the practice of law as much more than a profession. It is a calling grounded in empathy and a steadfast belief in justice. As the founder of LBD Law, PLLC, Lara leads a team that handles cases in criminal defense, family law, and juvenile offenses — areas where compassion and courage often make all the difference.

Her journey into law began with a deeply personal experience. “I was a child of divorce. It was tough going through that and feeling like I didn’t have a voice,” Lara says. “I want to speak up for others and help them be heard in a way people understand.”

That sense of purpose continues to guide her work today, whether she’s helping a parent fight for custody, defending someone facing charges, or advocating for a teen trying to turn their life around. “If you don’t have compassion and a passion for what you do, you can’t do this job,” she says. “I know my clients’ stories, and I listen to them. I feel what they feel.”

Her ability to connect on a human level doesn’t mean she shies away from being tough when it counts. “I know the law, and I don’t like a bully,” Lara says. “You can stand up for what’s right without losing your humanity. People don’t like being called out, but sometimes that’s what justice requires.”

That commitment leaves a lasting impact on the people she represents. One parent said, “Lara and her team were exceptional when dealing with my son’s juvenile case. I literally could not have asked for more and will forever be grateful for all she did.”

For Lara, it’s about helping people get the outcome they deserve. She recalls a recent case involving a man who had been in and out of the system since he was a teenager. “On paper, he should have gone back to prison,” she says. “But by telling his story and showing the court what really happened,



we were able to get him treatment instead. Seeing that outcome — it’s everything. It’s why I do what I do.”

She believes that when the legal system works as it should, justice prevails. “The legal system, when done right, works,” she says. “But you can’t do it alone. There are too many consequences people don’t realize until it’s too late. Google and AI are not lawyers. You need someone who truly knows the law and cares about you.”

Outside the courtroom, Lara stays grounded through reading, gardening, and cooking. “I really have to find the time to check out,” she says. “Spending time with my husband and our dogs helps me recharge.”

After more than 20 years in practice, Lara’s

passion has only deepened. “I love what I do,” she says. “People often say not to take things personally, but I believe that caring deeply is what makes us fight for others. If it doesn’t matter to you personally, you’re not truly invested.”
